Deposits: A deposit equal to one fifth of the applicable dues is required with your application.

Approval and Waiting List Provisions:

The Golf Committee at the bi-weekly meeting following receipt of a complete application and the applicable deposit reviews all applications for membership. New members whose applications are approved will be granted full membership unless at the time the application is approved, the membership is full, in which case non-resident applicants will be asked to await the next available membership.

Payments/Monthly Statements:

The balance of the dues will be due in five installments, which will be billed in January, February, March, April and May. Invoices for all Golf Club fees are due and payable in accordance with the policies and procedures of the Farmington Woods Master Association.
